Shepherd Stephanie Benedict facilitated training for the **Southeast Regional Comprehensive Center** (SERCC) in Biloxi, Mississippi. She presented an introductory session, "What is Indistar?" which included navigation of the online tools, state capacity and usage, implementation, and review of the additional options/features. Participants included

SERCC's **Beth Howard-Brown**, project director, and **Robin Jarvis**, program director. Also participating from SEDL were **Jason LaTurner**, **Crystal Darby**, **Heidi Goertzen**, **Shirley Carraway**, **Glenda Copeland**, **Don Doggett**, **Debbie Meibaum**, and **Robin Madison-Harris**.

The "Golden Parka Award" goes to Indistar shepherd Lois Myran, who has recently traveled to Idaho, Minnesota, and North Dakota. Lois, with the assistance of CIL's Indistar specialist Maureen Richel, met with **Idaho's** Wise Ways 10-member leadership team, lead by **Greg Alexander**, to review the Wise Ways tool's vision, education framework of effective practices, and the features of the state administration page. Wise Ways provides an evidence-base literature review for the Indistar indicators.

Lois also introduced **Minnesota's** Northern Star—that state's version of Indistar—to **Betsy Ziemer** and **Dwayne Strand** of the state leadership team and to continuous improvement coaches and SIG school principals new to the process. The team discussed successful implementation strategies of the 26 states using Indistar. In addition, Lois visited **South Dakota** to assist the Indistar LEAP team, including **Shawna Poitra** and **Heather Hoak**, with a new state feedback review process. The process is being used in 55 focus and priority schools in **Pierre, South Dakota**.

Meet the Staff Larry Kugler

Indistar Specialist



Larry Kugler assumed the role of Indistar "shepherd" after a 35-year career as an educator, bringing with him extensive classroom and administrative experience. Before joining the CIL Indistar team, he taught elementary and Title I high school students and also served as a reading specialist in the Fairfax, Virginia, County Public Schools (FCPS). As an administrator for FCPS—one of the largest and most diverse school systems in the country—Larry coordinated the district's Reading Recovery and Title I programs; for the latter, he initiated a professional development program that enabled a shift from a pullout model to an inclusion model. As coordinator of NCLB programs for FCPS, he provided professional development in data-informed decision making, led the development of a comprehensive school audit process, and served as the elementary representative in the development of a systemwide data enterprise system.

In addition, Larry coordinated a 2-year summer reading research study for Harvard University and has presented at numerous conferences. He has been a member of Phi Delta Kappa and the Reading Recovery Council of North America.

After retiring from FCPS, Larry consulted for the Mid-Atlantic Comprehensive Center, and authored, among other projects, a self-assessment rubric for Delaware as part of that state's effort to improve the district-level strategic planning.

When not working, Larry volunteers as president of Congregation Adat Reyim, a synagogue in northern Virginia. In addition, Larry has provided literacy training for five years in a rural primary school in South Africa, and, with his wife and many volunteers in Virginia, created a library of 23,000 trade books, available to both the school and the entire community.
